### Item 1: Chair's Report

Welcome to all members of the Committee and members of the Association for our Annual General Meeting this evening.

The Victorian Association for Philosophy in School has three purposes which underpin all we do. VAPS seeks to develop and promote philosophy for children in Victoria. This involves the exploration of philosophical concepts through critical and reflective thought, the discussion of philosophical issues and the encouragement of the Community of Inquiry methodology in classrooms.

I am very pleased to report that VAPS, once again, has had a very busy year, preparing, delivering, organising and coordinating an impressive array of activities. VAPS conducted the very successful 8th Annual Victorian Secondary Schools Philosothon in August. My thanks goes to Bonnie Zuidland, Janette Poulton and Laurance Splitter who coordinated this wonderful event. VAPS supported the Primary Schools Philosothon with the National Gallery of Victoria, and we have sought to establish a Middle Years Philosothon as an ongoing feature of our program.

VAPS has held and expertly led educational seminars and training on the Community of Inquiry methodology. Indeed, it was our model of training which has been adopted by FAPSA, the peak body for p4C organisations in the country, recognising VAPS's leadership in the provision of quality professional development.

Since the introduction of the VCE, VAPS has operated as the subject association supporting philosophy teachers across the state. Under this guise, we have hosted a number of VCE Network meetings on topics from the writing of SACs to preparing for the VCE Examination. VAPS has sought feedback from our members on the workshops offered as part of our program. From that feedback, VAPS has a number of interesting workshops planned for 2017. We also organised two Forums, with the generous support of The University of Melbourne. The Unit 3 Forum was very well attended, the Unit 4 Forum, less so, but a new date for this year's Unit 4 Forum will seek to address this.

One of our major focuses as an Association this year has been our continuing work on the SPP Ethical Capabilities Project, using the funds procured from a generous government grant. The SPP project has been ably led by the project coordinator, Deb Conwell, and her team of Hub Leaders. VAPS looks forward to the conclusion of the project this year and the chance to reflect on what will be, I am sure, a job well done.

I take this opportunity to thank all members of the Committee for their work over the last year. Your efforts have been well invested to the greater benefit of our members and, I trust, into your own interests and abilities.

I thank, especially, the Executive of the Committee. Josh Coller, the Treasurer, has done a wonderful job managing our finances. VAPS AGM Report 2016-2017

Education and Innovations Officer

VAPS was established in November 1990 – this is our 26th AGM.

It is the responsibility of the Education Officer to maintain and develop what is affectionately known as The Level One program. This is a course designed to lay the foundations for teachers and others to establishing the community of inquiry culture in their educational context. The pedagogy was inspired by the p4c project – the work of Lipman and Sharp.

### ACCREDITATION

Successful completion of a 2 day LEVEL ONE program results in a VAPS certificate of participation. Successful completion a 3 day LEVEL ONE program results in a FAPSA Level One certification.

### WHO CAN DELIVER A LEVEL ONE PROGRAM?

## Item 2: Education and Innovations Officer report

- Co-ordinator/s of a Level One program must be certified as FAPSA trained Level 2 facilitators demonstrating expertise both as an Educator and Philosopher. This role may be fulfilled by one or two personal.
- Presenters must have Level One training or be academically qualified as Philosophers.
- Coordinators are to be proactive in giving opportunity for level One trained persons to develop their skills as apprentice facilitators, or Level Two trained persons to develop their skills in presenting and organising as apprentice co-ordinators.
- Applicants to participate do not require any past experience; although it is recommended that they have participated in some form of VAPS activity (eg VCE network, Philosothons, etc).
- Independent co-ordinators must submit their list of presenters, Program notes prior to commencing their program, and participate in the assessment process of their participants if they wish their participants to receive accreditation from either VAPS or FAPSA.
- All programs must fulfil the requirements set out in the FAPSA guidelines.

### VAPS LEVEL ONE (2002-2017)

VAPS has been conducting Level One PD program since the early 1990s. The Education Officer has been overseeing these on behalf of VAPS since 2002, and VAPS has contributed significantly to the development of the FAPSA national guidelines.

### LEVEL THREE aka LEVEL TWO (2009-2013, 2016)

### LEVEL TWO (aka ADVANCED LEVEL ONE)
